This order is enforceable anywhere in this state by any law enforcement agency when signed by a judge, and upon service, may also be enforced by another state, an Indian tribe, or a territory of the United States. If respondent violates this order in a jurisdiction other than this state, respondent is subject to enforcement and penalties of the state, Indian tribe, or United States territory under whose jurisdiction the violation occurred.

8. The court clerk shall file this order with *Genesee County Sheriff's Dept* who will enter it into the LEIN.

9. Respondent may file a motion to modify or terminate this order. For ex parte orders, the motion must be filed within 14 days after being served with or receiving actual notice of the order. Forms and instructions are available from the clerk of court.

10. A motion to extend the order must be filed 3 days before the expiration date in item 7 or a new petition must be filed.

WHAT HAPPENED: As the treasurer of the Flint School board, I was chairing an open/public meeting (Finance Committee meeting of the whole). Approximately 20 minutes into the meeting, Danielle Greene interrupted another board member and I asked her politely if she could wait to speak next. She said "it's not going to happen" pushed back her chair, stood up, walked around the table of the executive secretary and stood over me while I was seated. She started poking her finger in the air immediately in front of my face as I was seated. I stood up to step back from her. She then grabbed my throat with one hand and the hair on the top of my head with the other and slammed my head against the conference table. She then proceeded to hit me down and punch me several times in the head. Several other board members and the administration pulled her off of me and I was immediately taken into an adjacent room for my safety.

WHAT HAPPENED: After Danielle Greene attacked me in the meeting, she has continuously and repeatedly participated and appeared in facebook live posts/broadcasts on her boyfriend's (Arthur Woodson) facebook page. He makes threats and accusations and she can either be heard in the background commenting and/or making a visual appearance and her own comments. She and Arthur Woodson are both "encouraging" his "followers" to "come after" me and to "show your support" for Danielle Greene. This includes, but is not limited to, announcing where my children attend school and making hate speech/comments about my gender identity/sexuality.
