21.11 APPROVAL OF AMENDMENT TO POLICY #5136 – PERSONAL COMMUNICATION DEVICES

To reduce distractions and enhance the safety of the learning environment by controlling cell phone usage within the school building, including unauthorized recordings on school property, the following resolution is proposed.

Be it Resolved, That

The Flint Board of Education,

- a.) Amend policy #5136-Personal Communication Devices to state no cell phone and other personal electronic devices are prohibited on school property and school buses during the school day;
- b.) Electronic devices include, but are not limited to; MP3 players, cameras, tape/CD players, video game devices, iPads, notebooks, tablets, eBooks, personal laptops, laser pointers, radios, pagers, beepers, walkie-talkies (long/short range), portable CB radios, portable short-wave radios, portable police scanning devices, and their earphone attachments, such as, but not limited to; earbuds, Bluetooth, and headphones are all prohibited; and
- c.) Authorizes Administration to enforce disciplinary actions for insubordination of established policy.

21.12 APPROVAL OF AMENDMENT TO THE CODE FOR STUDENT CONDUCT
